## WAIVER

In consideration of the Shire of Donnybrook-Balingup and Solahart Adventure Committee (the organisers) allowing entrants to participate to one or more activities associated with the event named "Donnybrook Adventure Relay" (the event) covering activities as described in the entry form and regardless of whether the activities are conducted on road, water, railway reserve or other areas. The entrant:

1. WAIVES all rights or causes of action which the Entrant might otherwise have against the organisers and its officials, employees, volunteers, agencies, contractors, and authorised personnel for any loss or damage however arising out of or in connection with the Entrant's participation in the event. This waiver includes all claims against the organisers notwithstanding any negligence default or lack of care on the part of the organisers.
2. RECOGNISES that the participant in the event will require physical fitness and the Entrant is satisfied that the Entrant has attained the level of fitness and skill required to safely participate in the event.
3. CONSENTS to receiving any medical treatment which the organisers consider appropriate in the event that the Entrant is injured suffers an illness in connection with the Entrants participation in the event.
4. AGREES to indemnify and hold harmless the organisers from any loss damage or injury whatsoever and however caused as a result of the Entrant's actions whether to the organisers or the property of the organisers relating to participation in the event
5. AGREES to abide by all rules and regulations laid down from time to time by the organisers relating to participation in the event.
6. AUTHORISES the organisers and any advertising or marketing agency acting on behalf of the organisers to take use and reproduce photographs and films of the Entrant participating in the event and to use the same for any purpose whatsoever including commercial advertising without any fee being payable to the Entrant.
7. WARRANTS AND DECLARES that the information set out in this document is true and correct in every particular.
8. ACKNOWLEDGES that the entrant is aware that participation in the event may be hazardous and may result in injury to the Entrant. The Entrant is aware that the organisers will ensure that the event will be operated with due care and skill and that the venue will be suitable for the purpose for which they are used. Otherwise the Entrant acknowledges that the Entrant uses the facilities entirely at the Entrant's own risk as the Entrant finds them and with prior knowledge of all dangers. The entrant agrees to observe all signs and comply with all directions of the organisers and the Entrant further acknowledges that the organisers may refuse entry to the Entrant to any of the event. The Entrant acknowledges that recklessness in the event or the failure to comply with the organisers directions will result in the denial of access to all of the event and subsequent facilities.
9. ACKNOWLEDGES that the entrant has read and clearly understood each of the terms and conditions hereof.
